Itinerary

Day 1 – Sunday, September 15:

Fly from home city to Kansas City and transfer to the Embassy Suites Kansas City Plaza hotel, your home for the next six evenings. This evening take a walk around the Plaza area with Tammy and Ross to get acquainted with its history and the area. Dinner is on your own this evening and there are several choices nearby.



Day 2 – Monday, September 16:

This morning starts off with a visit to the Nelson Atkins Art Museum, after visiting the museum there will be time for lunch in the area, then depart to the Steamboat Arabia which sank in the Missouri River in 1856. Preserved in mud, the steamboat Arabia is a modern-day treasure-hunting story. This evening will feature a dinner at a local restaurant with area alumni.

Day 3 – Tuesday, September 17:

Today is our All-American day with History and Hits. In the morning and afternoon, we discover the Truman Library & Museum, Truman Home, Independence Square and Clinton's Soda Fountain in Independence. After Independence head back to the hotel for a short break. This evening, we are off to the ballpark to see the Kansas City Royals take on the Detroit Tigers.



<u>Day 4 – Wednesday, September 18:</u>

Well start our day off at the Negro League Museum which is dedicated to preserving and celebrating the history of African-American baseball and its impact on America. After our visit to the Negro League Museum there will be time for lunch at one of the nearby famous Kansas City Barbeque restaurants. After lunch we will visit the American Jazz Museum, then return to the hotel for a free evening or optional Sporting KC Soccer game. (Details will be provided at a later time.)



Day 5 - Thursday, September 19:

Start the day off with a visit and tour of Arrowhead Stadium where the reigning Superbowl Champions Kansas City Chiefs play. After our visit to Arrowhead Stadium, we'll head to the National World War 1 Museum. After a visit to the museum, we will spend time in the Union Station area for lunch and shopping. We will also have time for the KC Wheel on your own if you choose and a trolley ride. We will then head back to the hotel for a quick dinner (on your own) and in the evening we will enjoy Peter Pan the Musical.

Day 6 – Friday, September 20:

Today we will visit Liberty, Missouri. We will visit Liberty Jail, Jesse James Bank Museum and have a walking tour of Liberty Civil War history. There will be time for lunch in the town square. After visiting Liberty, we will head back to the hotel. This evening is free, but we plan on offering an optional performance at the Kaufman Performing Arts Center. (NOTE: Their schedule and performances have not yet been announced).

Day 7 - Saturday, September 21:

Transfer to the airport for homeward bound flights.

Airfare is not included in the price of the tour. At a later date the preferred air schedule will be announced.
